- The District will have an appropriate National and State Criminal Background and Abuse Check made and inform the YEO of the results. - If there is a problem District will inform the YEO of the procedures to be followed

- If approved, the YEO will proceed to schedule an In-home interview with all members of the Host Family and complete Part III A & B of the application.
